INTERESTED BIDDER:

The Board of Supervisors is calling for sealed bids for ASPHALT COLD MIX. See attached specifications.

Per ton bid price must include all fees, taxes and include loading on county transport trucks. Graham County will pick up material at the plant. Plant will load material into county vehicles.

The supplier shall have material available as needed by the County. Per ton bid price shall be in effect from January 1, 2017 through December 31, 2017.

Successful bidder invoices for payment, at a minimum, must include the transport vehicle tare weight, gross weight, tonnage, price per ton (bid amount) and total invoiced amount. The invoice is the successful bidder's certification that the load meets or exceeds bid specifications.

All bids must be clearly marked **COLD MIX BID #A-2017-18** on the outside of the envelope and returned to the above address. If you have any questions contact Steven Puzas at 928-428-3652. The bid shall follow the specifications as closely as possible and will be rejected if it excludes or omits any portion thereof. The Board of Supervisors reserves the right to reject any or all bids. This proposal must include all charges as may be applicable. The Board of Supervisors will pay only the per ton amount submitted on the proposal upon receipt of material.

The estimated quantity is 0 - 300 ton on an "as needed" basis.

SPECIFICATIONS:

3/8" dense grade asphalt, 6.0 -7.5% MC-250 (+.25%) cold plant mix in accordance with the following gradation:

SIEVE SIZE	PERCENT PASSING
3/8"	90-100
No.4	<90
No. 8	32-67
No.200	2-10

Plasticity index shall be 0%. Acceptance shall be at plant site. No old or rejuvenated mix shall be accepted.

Mineral aggregate shall be 100% crushed & mineral aggregate and asphalt cement shall be mixed in the plant pugmill for a minimum of 30 seconds after the introduction of asphalt cement.

NON-COMLIANCE WILL RESULT IN BREACH OF CONTRACT AND GRAHAM COUNTY WILL MOVE TO THE NEXT BIDDER AFTER THREE (3) BUSINESS DAYS. BREACH BIDDER WILL BE RESPONSIBLE FOR PRICE DIFFERENCE.
