Based upon the  Petitioner's/Plaintiff's or  Respondent's/Defendant's "**Motion for More Time to Serve the Other Party**" and good cause appearing,

#### IT IS ORDERED:

If you allow your case to be dismissed, the only document you can file in your case is a "**Motion to Reinstate**" the Case. If the Clerk of Court accepts any document for filing after your case has been dismissed except for the "**Motion to Reinstate the Case**" your case is still subject to being vacated or canceled at any time a judicial officer discovers the dismissal. If your case is dismissed, any document filed after the dismissal date, except for the "**Motion to Reinstate the Case,**" is ineffective.
